This certifies that the mare owner has engaged one service to VS Total Heartthrob (Stallion) APHA #1058019 for the 2025 breeding season (February 5th - June 6th), unless special arrangements are made in writing. Note that VS Total Heartthrob may have blackout dates while competing. Please contact the stallion owner/manager for specific dates. The Mare Owner/Agent purchased a 2025 breeding from an SSA. The mare owner will be responsible for the booking fee and any shipping costs.

Any deviations must be made in writing as an addendum to this agreement and signed by both parties. The balance of the entire breeding fee is due before the first shipment of semen.

Booking

At the time of booking, the Mare Owner/Agent must provide the following:

- 1. A copy of the signed Mare Owner/Agent Agreement Form.
- 2. A copy of the signed shipping contract from Elwood Equine.
- 3. Rebreeds must fill out a new contract for the current year.
- 4. A copy of the Mare's registration papers (if leased, a lease agreement must be attached). The recorded owner will be included in the stallion breeding report.
- 5. The Booking Fee of \$350.

The Booking Fee guarantees placement in the stallion books for the breeding season. This includes all bookings, including auction and discounted breedings.

Fees

All fees are non-refundable and must be paid in full to the stallion owner/manager prior to semen shipment or placement on the stallion breeding report:

- Booking Fee: \$350
- Breeding Fee: Paid to SSA
- Cooled Semen Shipment: \$375
- Frozen Semen Shipment: \$475 (Contact stallion owner for availability)
- Counter to Counter Shipment: \$500
- Onsite pickup/collection at Elwood Equine: \$195
- Mare Re-breed Fee: \$500

Payment Information

- All payments for booking, breeding and shipping fees can be made via check, Venmo (Candice-Monsen), or PayPal (vstotalheartthrob@outlook.com).
- A processing fee will apply for PayPal transactions not submitted via friends and family.
- Payments must be made in full before semen is shipped.

Shipments

- Shipments are made on a first-come, first-serve basis. Early notification is advised.
- The Mare Owner or attending veterinarian MUST place semen order to Candice Monsen (801) 419-4476 by 4:00PM MST the day before shipment. All shipment requests must be canceled by 8:00 AM (MST) on the day of the shipment. If you fail to cancel, the shipment will be considered CONFIRMED and processed/charged accordingly.
- Stallion collection days: Monday, Wednesday, Friday. Please plan accordingly to have the mare checked with enough time to confirm and cancel following the timeframes above.
- Semen will not be shipped without prepayment.
- Information provided within your shipping contract with Elwood Equine will be used for shipment. Any changes to shipping instructions must be submitted with a new shipping contract 24 hours prior to ordering shipment.

Note: Stallion Owner and Shipping Facility are not responsible for shipment costs arising from losses, delays, or damage once the shipment leaves the collection facility.

Re-Breeds

The Mare may re-breed under the following conditions:

- If the Mare dies or becomes unfit to breed during the season, a substitute mare may be bred at no additional breeding fee.
- Live Foal Guarantee: A live foal is one that stands and nurses without assistance. If the foal is born dead, a veterinarian's certificate must be provided within 7 days. If the mare aborts or fails to conceive, she may return during the current breeding season. If too late, she may return the following year, provided the re-breed fee is paid.
- Color Guarantee:
- AQHA Only Mares: If the foal lacks qualified markings or traits for APHA Regular Registry, the mare may re-breed by submitting a new contract, paying the \$350 booking fee, and covering collection and shipping charges.
- APHA Mares: If the foal lacks qualified markings or traits for APHA Regular Registry, the mare may re-breed by submitting a new contract, paying the \$500 rebreed fee and covering collection and shipping charges.

Health and Liability

The mare and foal's health are the full responsibility of the Mare Owner before, during, and after breeding. In the event of the stallion's death or inability to breed, the agreement terminates, and the Stallion Owner has no further liability.

In the event that the stallion dies or becomes unfit for service, this agreement will immediately terminate. Stallion Owner shall have no liability to Mare Owner except notification of its occurrence.

- 1. This contract is a binding agreement between Elwood Equine, Stallion Owner, and Mare Owner.
- 2. A semen shipment includes the collection, evaluation, and preparation of semen and the delivery to the courier (FedEx, UPS or Counter to Counter Airline) and all shipping charges. The stallion is collected on Monday, Wednesday and Fridays only. Please arrange to have Mare checked on Sunday, Tuesday and Thursday and schedule shipments accordingly. Holidays may cause there to be limited or no shipping options available, so please keep the major holidays in mind when setting up your mare for breeding.
 - a. If Shipping Cooled Semen or Picking Up Semen, all semen collection fees must be paid at time of collection by the Mare Owner at \$375 per event for Fedex, \$500 for Counter to Counter, \$195 for customer pickup and \$475 for frozen semen. Semen will not be shipped without a complete contract and up to date payment.
 - b. Elwood Equine's semen shipping container must be returned and received within 7 days of receiving shipment or \$25 per day late fee will be charged. A fee of \$45 for boxes and \$450 for frozen shippers will be assessed and charged to the CC on file if the container is not returned to Elwood Equine. International shipping will be subject to additional fees.
- 3. Frozen semen shipments are on a first come first serve basis. We will ship out frozen semen as we have shippers available and make no guarantees of availability.
 - a. The first shipment will consist of 2 doses. If a pregnancy is not achieved using the initial two doses, a third dose will be released with an additional \$200 breed fee per dose. After the third dose, additional doses will be released at the stallion owner's discretion.
- 4. Elwood Equine makes no guarantee of cooled semen on any specific day. In the event of insufficient semen on a particular breeding day, Elwood Equine will ship on a first ordered, first served basis.
- 5. For the Mare owners requesting shipped semen Elwood Equine will guarantee only one dose of shipped semen; two doses will be shipped if available on the day of shipping.
- 6. Elwood Equine guarantees to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Elwood Equine does not guarantee fertility of any stallion but agrees to process each ejaculate to optimize 24-hour post cool motility. Every effort should be made to inseminate the mare within 24 hours after collecting from the Stallion. Mare Owner agrees to use all cooled semen provided by this Agreement for only the mare named in this Agreement and no other.
- 7. The Mare Owner or attending veterinarian MUST place semen order to Candice Monsen (801) 419-4476 by 4:00PM MST the day before shipment. All shipment requests must be canceled by 8:00 AM (MST) on the day of the shipment. If you fail to cancel, the shipment will be considered CONFIRMED and processed/charged accordingly.
 - a. Text messages are the preferred way of notification, but phone calls are accepted. Please be prepared with your name, Mare and shipment date. If there is no answer, please leave a voicemail with that information and the Stallion Owner and Manager will call you back as soon as possible. Requests via other sources will not be considered notification and will not be responded to.
- 8. The Mare Owner agrees that nothing shall be posted or shared via social media that could be negatively construed regarding Elwood Equine, Stallion Owner, nor any of its employees, agents, volunteers, or affiliates. Failure to do so may result in legal action regarding the content and damages associated from such action. Furthermore, Elwood Equine reserves the right to void this contract in the event this Agreement is breached. Any offending Mare Owner shall immediately forfeit any fees, payments or right to a rebreed
- 9. Any dispute related to this contract will be governed by, construed, and enforced in accordance with the laws of the State of Utah, and the venue of all disputes arising from this Breeding Agreement shall be Box Elder County, Utah.
- 10. If any provision of this Agreement shall be found invalid or unenforceable, it shall be deemed severed from this Agreement and the remainder of this Agreement shall be interpreted so as best to reasonably effect the intent of the parties
